AN ORDINANCE TO AMEND CHAPTER 82 SOLID WASTE OF THE AVA CITY CODE OF ORDINANCES BY REPEALING SECTION 132 AND ENACTING IN LIEU THEREOF A NEW SECTION 132 SOLID WASTE USER CHARGE.

WHEREAS, MoRS 71.680 gives jurisdiction and power to fourth-class cities to manage garbage and refuse collection and make rules and pass ordinances regulating, protecting and governing such collection,

THEREFORE BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF AVA, MISSOURI, that

Section 1. Section 82-132 Solid Waste User Charges shall be amended to read as follows:

a) *Residential collection service.* The minimum charge per month for the collection of residential solid waste shall be \$15.00 for once-a-week curbside pickup. The per-bag fee in excess of 140 gallons per week per customer shall be \$1.00 per bag.

(b) *Commercial bag.* The minimum charge per month for once-a-week curbside pickup shall be \$26.25 per month.

(c) *Bulk storage containers (dumpster).*

\*Customer may waive the monthly dumpster fee if they provide their own dumpster which has been approved by the Sanitation Superintendent (City Code 82-71).

(d) *Construction dumpsters definition:* A construction dumpster is to be used for intermittent or short-term projects where regular weekly long-term commercial dumpster service is not appropriate. Certain items are prohibited from these dumpsters such as demolition waste, roofing shingles, masonry debris, bricks, rocks, appliances, paint, oil, batteries, tires, brush, car parts, etc. that might damage the packing equipment on the truck. Appropriate uses would be new construction or remodeling debris, clean-up projects, etc. Acceptable items to be at the discretion of the sanitation department supervisor or his designated employee.

(e) *Construction dumpster policy, agreement and user fees:* A setting fee of \$30.00 will initially be charged that allows for setting of the dumpster for two weeks. Dumping fees are additional charges with a minimum of \$150.00. Dumpster will be picked up upon the close date of this agreement and dumped at that time and customers will be charged according to the cost of disposal. It is the contracting customer's responsibility to contact city utilities to request additional dumping or resetting of dumpster during the two week

period. If the dumpster is set, but has not been used during the two week period, a reset might not be possible until all other requests have been completed and a unit becomes available. Any delays in allowing the dumpster to be picked up at the appropriate time will result in a Five Dollars (\$5.00) per day fee until time the dumpster can be picked up.

(f) These rates will go into effect on the utility bill prepared in July 2009 and due in August 2009.
