

AN ORDINANCE TO REPEAL SECTION 98.34 RATE SCHEDULE IN CHAPTER 98 UTILITIES, ARTICLE II WATER SYSTEM AND 98.305 USER CHARGES FOR WATER OR WATER SERVICES IN ARTICLE V WATER AND SEWER USER CHARGE SYSTEM AND REPLACE IN LIEU OF A NEW SECTION 305 USER CHARGES FOR WATER OR WATER SERVICE OF THE CODE OF ORDINANCES OF THE CITY OF AVA, MO.

WHEREAS, The City of Ava, MO deems it in the public interest and general welfare to provide a municipal distribution system for drinking water, and

WHEREAS, The Code of Ordinances of the City of Ava, MO sets out policies and procedures for the utilities services,

THEREFORE BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF AVA, MISSOURI.

Section 1. Chapter 98 Utilities Article II Water System Section 34 Rate Schedule is repealed.

Section 2. Chapter 98 Utilities Article V Water and Sewer User Charge System Section 305 User charges for water or water service is repealed and replaced in lieu of with a new Section 305 User charges for water or water service.

Section 3. The new Section 98-305 shall read as follows:

(a) The City of Ava, Missouri, Code of Ordinances authorizes the board of aldermen to fix the rate schedules of water and water service in Section 98-305.

(b) The rate schedule for all classes of water service is hereby established as follows:

Minimum bill (includes usage allowance of 1,000 gallons)

Minimum Bill	Fiscal Year
\$ 9.78	FY 2009
\$10.02	FY 2010
\$10.27	FY 2011
\$10.53	FY 2012
\$10.79	FY 2013

Unit charge (after the first 1,000 gallons)

Unit Charge	Fiscal Year
\$1.60	FY 2009
\$1.64	FY 2010
\$1.68	FY 2011
\$1.72	FY 2012
\$1.76	FY 2013

(c) The rate for tank sales to set the charge for bulk sales of water as follows:
Charge for first 1,000 gallons Sixty dollars (\$60); then Twenty dollars (\$20) per thousand for every thousand gallons after the first one thousand.

Section 4. This ordinance shall take effect and be in force from and after its passage and approval by the Board of Aldermen of the City of Ava, Missouri. All ordinances or parts of ordinances in conflict with the terms hereof are void and of no effect.
